The TRES PTA is holding its 1st Annual Talent Show on the evening of **Friday November 18, 2016!** All current TRES students are welcome to participate. We're looking for singers, dancers, actors, comedians, magicians—or any talent your child may choose to share with our school. (Sorry, no lip synching). Please complete the entire attached application and return it to school. Applications must be filled out completely and signed by a parent or it will be returned. Each student must complete an application, even if performing in a group.

All applications due Wednesday October 12, 2016

Show Guidelines

- Students may participate in ONE ACT— a solo act OR a group act. All students who audition will be allowed to participate. Auditions are held to ensure the students are prepared to perform. EACH participant must complete and return a signed application form.
- Acts should not exceed 2–3 minutes in length. This may be adjusted up or down based on the number of participants. Parents and students will be informed of any change prior to auditions once all applications are received.
- All students must attend both the after school audition (October 24th or October 25th) and the dress rehearsal on November 16th. There will be no exceptions to this requirement. Parents must provide transportation. Parents of younger children are strongly encouraged to attend both the audition and rehearsal with their student.
- Song choices will be granted on a first come, first served basis. The number of times a song may be used will be limited. Students will be notified immediately if they need to pick a different song.
- All performances must follow school appropriate language, dress code and music choice and must be approved by the talent show parent volunteer committee.
- Music must be an MP3 file on a blank CD or thumb drive labeled with student or group name and edited to appropriate length prior to audition. Singers must use a "no vocal" or karaoke version of their song.

1. Parents and students have read the attached Show Guidelines.
2. Students participating in the talent show must attend their assigned after school audition on Oct. 24th or 25th (schedule will be sent home once all applications are received) **and** the Nov. 16th dress rehearsal. Parents must provide transportation. Parents of younger children are strongly encouraged to attend the audition and rehearsal with their child.
3. Parents must approve their student's act and music prior to the auditions. All performances must follow school appropriate language, dress code and music choice.
4. Any required music must be an MP3 file on a blank CD or thumb drive. edited to the appropriate length (2-3 minutes maximum) and left with the committee on the day of the audition. Singers must use a "no vocal" or karaoke version of their song. Parent volunteers will not be assisting with editing music.
5. Please remember that the talent show is run completely by parent volunteers. Students are expected to act responsibly and be on their best behavior. Students may not be allowed to participate if their behavior is not within school guidelines.
6. Students should arrive at the audition prepared to perform their entire act on stage—the act does not need to be perfect at the audition but students should practice before this date.
